Constitution

Section I – NAME

The name of this Council is **Promontory Heights Elementary Community School Parent Advisory Council.**

The Council will operate as a non-profit organization with no personal financial benefit accruing to members.

The business of the Council will be unbiased in respect of race, religion, gender, politics, sexual orientation, and physical or mental ability.

Section II - PURPOSES OF THE COUNCIL

The purposes of the Council will be:

- 1. To promote the education and welfare of students in the school.
- 2. To encourage parent involvement in the school, and to support programs that promote parent involvement.
- 3. To advise the school board, principal, and staff on any matter relating to the school programs, policies, plans and activities.
- 4. To participate in the work of the school planning council through the Council's elected representatives.
- 5. To promote the interests of public education and, in particular, the interests of **Promontory Heights Elementary Community School**.
- 6. To provide leadership in the school community.
- 7. To contribute to a sense of community within the school and between the school, home, and neighbourhood.
- 8. To provide parent education and professional development, and a forum for discussion of educational issues.
- 9. To assist parents in obtaining information and communicating with the principal and staff about their child's progress or other concerns.
- 10. To assist the principal and staff in ensuring the highest safety standards are maintained in the school and neighbourhood.

- 11. To organize and support activities for students and parents.
- 12. To provide financial support for the goals of the Council, as determined by the membership.
- 13. To advise and participate in the activities of Chilliwack School District 33 District Parent Advisory Council, and the BC Confederation of Parent Advisory Councils

Section III -- INTERPRETATION OF TERMS

- "AGM" or "Annual General Meeting" means the election of executives which occurs annual in May.
- "community organizations" means groups that demonstrate an interest in education and are not already included in the scope of the Promontory Heights Elementary Community School Parent Advisory Council's constitution and bylaws
 - "district" means School District No. 33
- "DPAC" or "district parent advisory council" means the parent advisory councils organized according to the School Act and operating as a district parent advisory council in School District No. 33
- "PAC" or "parent advisory council" means the parents organized according to the School Act and operating as a parent advisory council in **Promontory Heights Elementary Community School**
 - "parent" is as defined in the School Act (https://www.bclaws.gov.bc.ca)
- "school" means any public elementary or secondary educational institution as defined in the School Act operating within School District No. 33

Bylaws

Section I - MEMBERSHIP

Voting members

1. All parents and legal guardians of students registered in **Promontory Heights Elementary**Community School are voting members of the **Promontory Heights Elementary**Community School Parent Advisory Council.

Non-voting members

- 14. Administrators and staff (teaching and non-teaching) of **Promontory Heights Elementary**Community School may be invited to become non-voting members of the Council.
- 15. Members of the school community who are not parents of students registered in the public school system may be invited to become non-voting members of the Council.
- 16. At no time will the Council have more non-voting than voting members.

Compliance with bylaws

5. Every member will uphold the constitution and comply with these bylaws.

NOTE: determine the voting/non-voting rights of school staff who also have children registered at the school they teach in. Possible wording could be "In the instance of a staff member also being a parent of a student registered at (name of your school), the status of parent shall prevail."

Section II – MEETINGS OF MEMBERS

General meetings

- 17. General meetings will be conducted with fairness to all members.
- 18. General meetings shall be held on a regular basis during the school year to conduct current business (July to September).

19.	General meetings will be held not less than four times during the school year. One of those meetings will be the Annual General Meeting to be held in May.
20.	The AGM shall be held each May and shall include: Presentation of the minutes from the previous AGM; Presentations from the reports from the executive and any committee chairs; Election of the new executive officers; Approval of financial statements and proposed budget; and An audit or financial review report on the PAC finances (this is particularly important if there is a change in Treasurer).
21.	The Principal and staff (teaching and non-teaching) are encouraged to attend general meetings of the PAC as observers and liaisons with parents.
	Conduct
22.	A PAC meeting shall not be a forum for the discussion of individual school personnel, students, parents, or other individual members of the school community.
23.	The Council will refrain from partisan political action or other activities that do not serve the interests of the school or the public school system.

24.	Members will be given reasonable notice of general meetings.

Section IV -- EXECUTIVE

Role of executive

1. The executive will manage the Council's affairs between general meetings.

Executive defined

2. The executive may be comprised of the Chairperson, Vice-Chairperson, Treasurer, Secretary, Fundraising Co-Ordinator, and such other members of the Council as the membership decides. In the event all positions cannot be filled, the minimum to be viable is three, Chairperson, Secretary, and Treasurer.

Eligibility

3. Any voting member of the Council is eligible to serve on the executive, except full-time employees at the school or elected officials of School District No. 33 or the Ministry of Education. An exception will be made if a vacant position remains unfilled. A School District No. 33 employee can serve in an executive position, providing they are a parent of a child in the school, until the position can be filled by a parent not employed by the district.

Election of executive

- 32. The executive will be elected at each annual general meeting.
- 33. Elections will be conducted by a member who is not seeking a nomination or position. In the absence of an eligible member, the vote will be turned over to an administrator to conduct.
- 34. No two members of the same family may serve on the executive at the same time.

Term of office

- 35. The executive will hold office for a term of one year beginning July 1st, in accordance with the fiscal year.
- 36. No person may hold the same executive position for more than four years.

NOTE: It is recommended a member only holds one executive position at one time.

Vacancy

9. If an executive member resigns or ceases to hold office for any other reason, the remaining executive members may appoint an eligible member of the Council to fill the vacancy until the next Annual General Meeting.

Removal of executive

- 37. Executive members must make every effort to attend all meetings; if it is not possible they must notify the Chair or Vice-Chair in a timely manner. If an executive member is not or unable to perform their duties they may be removed from their position before the expiration of their term.
- 38. The members may, by a majority of not less than 75% of the votes cast, remove an executive member before the expiration of his or her term of office, and may elect an eligible member to complete the term.
- 39. A written notice specifying the intention to make a motion to remove the executive member must be given to all members no less than 14 days before the meeting.

Remuneration of executive

13. No executive member may be remunerated for serving on the executive, but may be reimbursed for expenses reasonably and necessarily incurred while engaged in the Council's affairs.

Section V – EXECUTIVE MEETINGS

Meetings

1. Executive meetings will be held at any time deemed necessary by the executive. The purpose of these meetings is to carry on business between general meetings. An effort will be made to hold 4 executive meetings a year.

Quorum

40. A quorum for executive meetings will be a majority (50% plus 1) of the members of the executive.

Notice

41. Executive members will be given reasonable notice of executive meetings.

Voting

- 42. All matters requiring a vote at executive meetings will be decided by a simple majority of the votes cast (50% plus 1).
- 43. In the case of a tie vote, the chair does not have a second or casting vote and the motion is defeated.
- 44. Minutes will be maintained for all executive meetings.

Q

District Parent Advisory Council representative

45. One representative to the School District No. 33 District Parent Advisory Council may be elected annually from among the voting members who are not employees or elected officials of School District No. 33 or the Ministry of Education.

Election of DPAC representative

46. The election of the representative to the DPAC must be a simple majority of votes cast.

Term of office

3. DPAC representative will hold office for a term of one year in accordance with the fiscal year.

Vacancy

4. If a DPAC representative resigns or ceases to hold office for any other reason, the membership may elect an eligible member of the Council to fill the vacancy for the remainder of the term. Such an election must be a simple majority of votes cast.

External Committees

- 47. The membership or executive may elect or appoint a PAC member to represent the Council on an external committee or to an external organization.
- 48. The representative will report to the membership or executive as required.

Section VII - CONDUCT OF EXECUTIVE AND REPRESENTATIVES

Code of ethics

1. On election or appointment, every executive member and representative must sign and agree to abide by a code of ethics acceptable to the membership.

Representing the Council

2. Every executive member and representative must act solely in the interests of the membership and of the Council.

Privilege

3. Any information received in confidence by an executive member or representative from school personnel, a student, parent, or other member of the school community is privileged and must not be divulged without permission of the person giving the information.

Disclosure of interest

- 49. An executive member or representative who is interested, either directly or indirectly, in a proposed contract or transaction with the Council must disclose fully and promptly the nature and extent of his or her interest to the membership and executive.
- 50. Such an executive member or representative must avoid using his or her position on the Council for personal gain.

Section VIII - DUTIES OF EXECUTIVE AND REPRESENTATIVES

A. The Chairperson will

- (a) speak on behalf of the Council
- (b) consult with Council members
- a. provide leadership
- b. preside at general and executive meetings
- c. ensure that an agenda is prepared and presented for all meetings
- d. be current on the Promontory Heights Elementary Community School PAC Constitution, Bylaws and Meeting rules
- e. read information sent to the PAC and distribute information to the members
- f. consult PAC members regularly and keep them informed

- g. prepare a notice of meeting and agenda highlights to be included in the parents' newsletter and other digital media and post on school website and/or bulletin board
- h. appoint committees where authorized by the membership or executive
- i. ensure that the Council is represented in school and district activities
- j. ensure that Council activities are aimed at achieving the purposes set out in the constitution
- k. be a signing officer for cheques and documents
- 1. submit an annual report
- m. ensure that all relevant information regarding this position is passed onto the succeeding Chairperson by the June general meeting
- n. ensure a Nominations Committee is formed in March

B. The Vice-Chairperson will

- o. support the Chairperson
- p. assume the duties of the Chairperson in the Chairperson's absence or upon request
- q. assist the Chairperson in the performance of his or her duties
- r. accept extra duties as required
- s. know where to find resources to assist members
- t. may be a signing officer for cheques and documents
- u. ensure all relevant information regarding this position is passed on to the succeeding Vice-Chairperson by the June general meeting

C. The Secretary will

- v. ensure that members are notified of meetings
- w. record and file minutes of all meetings (general, executive and AGM)
- x. compose and provide the minutes of all PAC meetings within two weeks
- y. record the attendance at all general and executive meetings
- z. keep an accurate copy of the constitution and bylaws, and make copies available to members upon request
- aa. prepare and maintain other documentation as requested by the membership or executive
- bb. issue and receive correspondence on behalf of the Council
- cc. ensure safekeeping of all records of the Council
- dd. may be a signing officer of cheques and documents
- ee. ensure all relevant information regarding this position is passed on to the succeeding Secretary by the June general meeting

D. The Treasurer will

- ff. be a signing officer of cheques and documents
- gg. ensure all funds of the Council are properly accounted for
- hh. deposit all funds collected on behalf of the PAC in an account at a recognized financial institution approved by the PAC
- ii. disburse funds as authorized by the membership or executive
- jj. ensure that proper financial records and books of account are maintained
- kk. ensure all expenditures are authorized by motion or through the approved budget
- 11. report on all receipts and disbursements at general and executive meetings
- mm. make financial records and books of account available to members upon request
- nn. have the financial records and books of account ready for inspection or audit annually
- oo. with the assistance of the executive, draft an annual budget outlining the basic annual expenditures to be presented at the PAC AGM
- pp. prepare an annual report for the PAC AGM
- qq. ensure that another signing officer has access to the financial records and books of account in the treasurer's absence
- rr. ensure that all relevant information regarding this position is passed on to the succeeding Treasurer after completing the fiscal year end

E. The immediate Past Chairperson can

- ss. advise and support the membership and executive
- tt. serve as an advisor to the Chairperson
- uu. provide information about resources, contacts, and other matters
- vv. ensure that all relevant information regarding this position is passed onto the succeeding Chairperson by the June general meeting
- ww. submit an annual report for the General Meeting

Section IX – COMMITTEES

51. The membership and executive may appoint committees to further the Council's purposes and carry on its affairs.

3. All funds of the Council must be kept on deposit in the name of the Council in a financial institution registered under the Bank Act.				
Signing authority				
4. The executive will name at least three signing officers for banking and legal documents. Two signatures will be required on all of these documents.				
Annual budget				
5. The executive will prepare a budget and present it to the membership for approval before the current budget expires.

Treasurer's report		
59. A treasurer's report will be presented at each general meeting.		

Auditor

60. Members at a general meeting may appoint an auditor.

Section XI - CONSTITUTION AND BYLAW AMENDMENTS

- 61. The members may, by a majority of not less than 75% of the votes cast, amend the Council's constitution and bylaws.
- 62. A written notice specifying the proposed amendments must be given to the members not less than 14 calendar days before the meeting.
- 63. Where the proposed amendments exceed one page, they need not be given to every member, but must be posted in a conspicuous place in the school or made accessible to all members.

64. A review of the Constitution and Bylaws shall take place every 3-5 years by a committee consisting of at least three members including one executive member.

Section XII – PROPERTY IN DOCUMENTS

All documents, records, minutes, correspondence, or other papers kept by a member, executive member, representative, or committee member in connection with the Council shall be deemed to be property of the Council and shall be turned over to the president when the member, executive member, representative, or committee member ceases to perform the task to which the papers relate.

A copy of the adopted Constitution and Bylaws must be sent to the Superintendent of Schools of the Chilliwack School District along with a copy of the minutes in which the document was approved in order for the PAC to be recognized.

Any subsequent amendments to the Constitution and Bylaws must be forwarded to the Superintendent in the form of the amended and adopted document.

Section XIII - DISSOLUTION

- 65. In the event of winding up or dissolution of the Council, and after payment of all debts and costs of winding up or dissolution, the assets and remaining funds of the Council shall be distributed to another parent advisory council or councils in School District No. 33 having purposes similar to those of the Council, as the members of the Council may determine at the time of winding up or dissolution.
- 66. In the event of winding up or dissolution, all records of the Council shall be given to the principal of Promontory Heights Elementary Community School.
